This document contains information on the export and resale of the CRYPTO-BOX® products from MARX®.

1. Commodity Code

2. Country of Origin

The country of origin of the CRYPTO-BOX is Germany, European Union. The Long-term supplier's declaration (CCI) for products having preferential origin status is available upon request. 3. Dual-Use Regulations

The CRYPTO-BOX is not subject to the Export List and the Dual Use List in accordance with EU Regulation 2021/821. In Annex I, → Part VII – CATEGORY 5 → Part 2 - "INFORMATION SECURITY", "Note 3: Cryptography Note" states, that 5A002, 5D002.a.1., 5D002.b. and 5D002.c.1. do not control items mentioned in paragraphs a) and b) which is true for the CRYPTO-BOX.

4. US Export Control Classification Number (ECCN)

The content of U.S. made technology of the CRYPTO-BOX is below the 25% de-minimis threshold according to § 734.4 of the EAR and is therefore not subject to the US Export Administration Regulation. Furthermore, BIS (U.S. Department of Commerce, Bureau of Industry and Security, Washington D.C.) confirmed on 23rd November 2018, that CRYPTO-BOX for the purpose of software licensing and protection are classified as EAR99, NLR (No License Required).
